POWERS AND DUTIES OF THE MANAGING TRUSTEE:

1. The Managing Trustee of the Trust shall be elected by the members of the Trust from among themselves. He shall hold office ordinarily for three years. He is eligible for re-election.

2. The Managing Trustee shall cause minutes to be duly entered in books provided for the purpose.

- (a) of all appointments of officers and employees;
- (b) of the names of the members present at each meeting of the Trust and of any sub-committee;
- (c) of all ordors made by the Trust and sub-committee; and
- (d) of all resolutions and proceedings of the meetings of the Trust Board and of the sub-committees.

Every such minutes of any meeting of the Trust Board or any sub-committees will be approved and ratified by the Chairman of the next succeeding meeting of the corresponding body and shall be receivable as prima facie evidence of the matters stated in such minute.

3. The Managing Trustee shall carry on all correspondence relating to the Schools and other Institutions of the Trust with the Central Board of Secondary Education and connected Authorities and for the purposes of the Madras Educational Rules, the Grant-in-Aid Code, University Regulations, etc., and shall transact all the official business of the Trust and of the Board of Trustees according to the Resolutions and bye-laws passed under these Rules.

4. The Managing Trustee shall be the custodian of the title deeds, records and other documents relating to the transactions of the Trust and shall in charge of all moveable and immoveable properties belonging to the Trust.
